ITINERARY FOR OUR AUSTRIAN LAKES/SOUND OF MUSIC COUNTRY TOUR:

DAY 1 - BOSTON-MUNICH, GERMANY: We depart Boston's Logan Airport on our transatlantic flight to Munich (*via an intermediate city*). Full food and beverage service is offered while aloft, as well as stereo headsets for our listening pleasure.

DAY 2 - MUNICH-TYROL: Upon arrival in Munich, we will be met by our tour manager and board our private motorcoach and travel into the Alps, the Tyrol, and finally to the centrally-located *Hotel Grauer Bar* (or similar) which will be our base for the next seven nights. There will be time to relax before enjoying a traditional welcome dinner at the hotel to celebrate our arrival. (D)

DAY 3 - INNSBRUCK: After a leisurely breakfast, there will be a tour of the old town during which we will see the Hofburg Palace, Innsbruck's ornate cathedral, and the famous "Golden Roof". There will be time to explore the town's cobbled streets and shops. This afternoon is at leisure, but we suggest a visit to the Olympic ski jump, offering spectacular views of the city. (B, D)

DAY 4 - SALZBURG: One of the highlights of our week today, as we travel to the magical city of Salzburg, home of Mozart and "The Sound of Music". A local guide will take us on a tour of the city where we will discover the history behind this city's favorite son, and explore the wonderful architecture, historical sites, and beautiful shops on Getreidegasse. This afternoon will be at leisure before returning to Innsbruck in time for dinner. Time permitting, we will stop at Wattens and explore the home of Swarovski Crystal. (B, D)

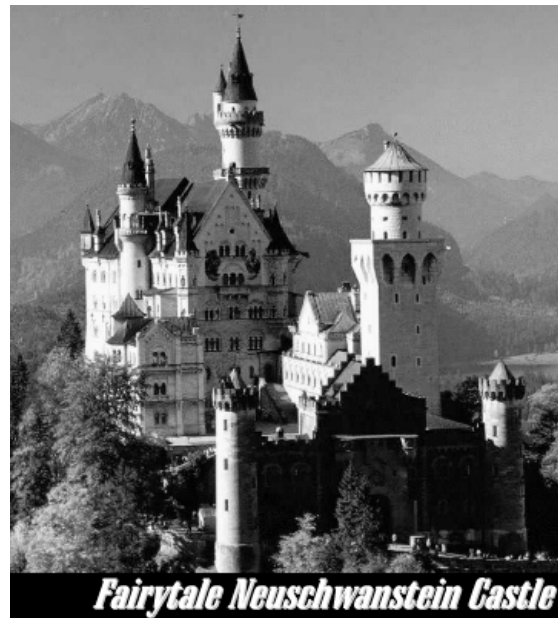
DAY 5 - MUNICH: Today, we visit world-famous Munich for guided sightseeing. We will include a visit to Oktoberfest. Oktoberfest is a two-week festival held each year in Munich during late September and early October. It is one of the most famous events in the city, and the world's largest fair, with some six million people attending each year. Sample the special beers and local foods on your own. Included in our day is a typical Bavarian dinner in one of the Oktoberfest tents. Return to our hotel for overnight. (B, D)

DAY 6 - VIPITENO & THE DOLOMITES: After breakfast, travel south over Europe's highest road bridge, across the Brenner Pass and into Italy. Stop in Vipiteno, a tax haven perfect for purchase souvenirs before continuing on our journey along the magnificent Dolomite Mountains to Lienz for lunch. Passing Austria's highest mountain, Grossglockner, the famous ski resort of Kitzbuehel makes the ideal spot for coffee and cake before returning to Innsbruck for dinner and overnight. (B, D)

DAY 7 - EAGLE'S NEST-KONIGSEE: After breakfast, cross back over into Germany for a visit to Obersalzberg, location of the Eagle's Nest, Hitler's summer home perched high in the Bavarian Alps, with beautiful views of both Germany and Austria. Afterwards, we will have lunch at the Konigsee (*King's Lake*), the deepest and cleanest lake in Germany. Boat cruise on Konigsee. Return to the hotel for dinner and overnight. (B, L, D)

DAY 8 - BAVARIA & NEUSCHWANSTEIN: Our last full-day in the region today, as we cross the border into Germany and travel via the town of Garmisch Partenkirchen and the home of the Passion Play, Oberammergau, where there will be a brief stop. Next, we will continue-on to the fairytale castle of Neuschwanstein. This magnificent castle is probably the best known of King Ludwig's many monumental achievements and we will be hosted on a guided tour of the interior. Return to Innsbruck early afternoon, with time at leisure for relaxation, exploring, or last minute shopping. Tonight, enjoy a special "Farewell Dinner" with our traveling companions. (B, D)

DAY 9 - INNSBRUCK-MUNICH-INTERMEDIATE CITY-BOSTON: After a final breakfast and hotel check-out, it is time to bid farewell to the Austrian Tyrol, transferring back to Munich for our flight to Boston (*via an intermediate city*). (B)
